Summary of Procurement Guidelines in Nigeria

Procurement Framework in Nigeria

Legal framework

- Primary law: Public Procurement Act 2007 governs public procurement across federal MDAs and provides the procurement principles, methods, and institutional roles.
- Regulator: Bureau of Public Procurement (BPP) issues guidelines, circulars and certificates of "No Objection" and recommends threshold adjustments to the President and approving authorities.

Core principles

- Transparency, Competition, Accountability, Value for Money, Equality of Access, and Efficiency. These guide every stage from planning to contract management under the Act and BPP guidance.

Procurement methods and recent thresholds

Common procurement methods

- Open/National/International Competitive Bidding
- Restricted Bidding
- Request for Quotations (RFQ) / Request for Proposals (RFP)
- Two-stage tendering (for complex projects)
- Direct Procurement (limited to emergencies, single-source situations)
- Prequalification (for large or technical works).

Revised approval and method thresholds (summary)

Notes: International/National Competitive Bidding required for goods \geq N1 billion and works \geq N5 billion; RFQs allowed for goods/non-consultant services below ~N30 million and works below ~N50 million under the revised guidance.

Typical procurement lifecycle (practical steps)

- 1. **Planning & Needs Assessment** prepare Procurement Plan, budget alignment, define specs.
- 2. **Method Selection & Approvals** choose method consistent with thresholds and obtain necessary No Objection or MTB/PTB/FEC approvals.
- 3. Advertising & Solicitation publish tender notices where required; issue RFQs or bidding documents.
- 4. **Bid Submission & Opening** time-stamped submissions; public opening for competitive tenders.
- 5. **Evaluation & Due Diligence** technical then financial evaluation, verification of documents, conflict-of-interest checks.
- 6. Award & Contracting award recommendation, approval, contract preparation and signing.
- 7. Implementation & Contract Management monitor deliverables, variations, payments, performance bonds where applicable.

8. Audit & Reporting — maintain documentation for internal/external audit and submit reports to BPP as required.

Roles, oversight and compliance

- BPP: issues guidelines, reviews major procurements, issues No Objection certificates, capacity building and enforcement.
- Accounting Officers / Tenders Boards: ensure internal compliance and carry delegated procurement authority within set thresholds.
- Independent Audit and Anti-corruption Agencies: review contracts, investigate infractions and enforce sanctions where breaches occur.

Common procurement violations and best practices

- Common violations: splitting contracts to avoid thresholds, awarding without competition, poor documentation, conflicts of interest, non-adherence to technical specifications.
- Best practices: maintain clear procurement plan, strictly follow threshold-based approval lines, record decisions, run competitive processes where possible, declare and manage conflicts, and document evaluations and contract variations.
